## Dear Polk Street Area Merchants and Restaurants;

The Polk District Merchants Association and Steven Restivo Event Services, LLC invite you to participate in the *Ist Annual Free Polk Street Blues Festival*. It is our goal to generate as much publicity for the district as possible. This is now the only free Blues Festival in San Francisco. Working together, we feel this Festival could grow and expand into one of the largest events in the Bay Area over the next few years and bring thousands of potential shoppers to the street.

The event will take place on Saturday, September 25 & Sunday, September 26, 2010 from 10:00 am to 6:00 pm. Polk Street from Pacific Street to Union Street, Vallejo Street from Polk Street to Van Ness and the intersection of Green and Polk will be closed to vehicle traffic from Saturday, September 25 at 12:01 am, until Sunday, September 26 at 11:59 pm. Broadway will remain open at all times during the event. The Festival will feature two main stages of live Blues, a local merchant market place, arts and crafts, gourmet food and beverage booths, a large family area, a cooking demonstration stage, bistro style seating areas and much more.

Polk District Merchants who are members of the Polk District Merchants Association will be given first option to purchase a booth space at the event. All merchant applications received will be reviewed by the Festival committee. Participating merchants who qualify must sell original items. You must staff your booth for the complete duration of the event both days. The space fee for qualifying members of the Polk District Merchant Association is \$200, a discount of \$100 off the list price. This fee is for a 10 x 10 space only; it does not include a booth, tables or chairs. If you would to rent those items to include set up and breakdown, it is an additional \$250, which is our cost. Polk District Restaurants who are members of the Polk District Merchants Association who wish to participate will be given first option to purchase a food booth at the event. The space fee for food booths is a flat fee of \$900, a discount of \$100 off the list price. This fee includes a 10ft x 10ft health department approved booth, a 10ft x 10ft delineated space behind the booth for your cooking area, your San Francisco health department permit fee and your San Francisco Fire department permit fee. In addition, all food vendors may sell non-alcoholic beverages from their booths. Also, all food vendors are required to use compostable products, i.e.; paper plates, napkins, forks, cups, etc.

<u>If you are interested in being part of the Cooking Demonstration Stage</u>, which should receive a tremendous amount of publicity, please let us know by filling out that section of the application. There is no fee to participate in the cooking demo. We would need you to have someone from your restaurant do the demo for about 60 minutes on either day. We do these demos at a number of our Festivals and they are a huge draw.

In addition to the above options, we will be creating a "Polk Street Merchants Marketplace" where small retail Businesses/Merchants from the district can sell their wares or just promote and market their business. We are designating a 20ft wide x 40ft long tent in the center of the Festival that will have 15-4ft tables inside of it. Each 4ft table will be allocated to a qualifying retail small Business/ Merchant. All applications received will be juried by the Festival committee. The fee for participating in the Merchant's Market is \$75 for Polk District Merchant Association members and \$100 for non-Association members. If you are interested in participating in the Merchant Marketplace, please fill out the application below and check the appropriate box. You must staff your table for the complete duration of the event both days.

To apply for the event, please fill out the application form attached to this document and return it by February 15, 2010 with 4 photos of the work displayed regularly in your store and your check payable to Steven Restivo Event Services, Ilc. If accepted you will receive a confirmation letter within 7 days, then we will email/mail a participant packet and your free promotional postcards to you 30 days prior to the event. Please make a copy of this application for your files.
